POSITION SUMMARY:

Performs ultrasonic imaging and related procedures in OB/GYN area. Demonstrates anatomy for interpretation and/or intervention by or at the request of a licensed practitioner. May assess fetal status through biophysical profile and amniotic fluid index. Exercises professional judgment in performance of services and maintains a demeanor complementary to medical ethics. Applies appropriate patient care and recognizes patient conditions essential for successful completion of the procedure.

- .2. Performs diagnostic ultrasound procedures.

 - C. Selects and operates ultrasound equipment, and associated devices to achieve desired results.
 - D. Determines ultrasonic frequencies and appropriate transducers for the anatomic area of interest.
 - E. Evaluates images for technical quality, assuring proper identification is recorded.
 - F. Stores images in electronic medical records with a back up.
 - G. Generates reports in eCW for the performed examinations.
 - H. Uses appropriate billing codes.
- Coordinates patient exams with other departments and with radiologists.
- 4. Maintains confidentiality of patient's records and files.
- 5. Provides patient education.
- 6. Assumes responsibility for assigned area and reports equipment malfunction.
- 7. Provides practical instruction for students and/or health care professionals.
- 8. Participates in the department's quality assessment and performance improvement plan. May be responsible for specific quality control duties in the assigned area.
